An external reviewer, Dr. John Mayfield, former Associate Dean of the Graduate School, Iowa State University, evaluated the twenty-nine (29) proposals submitted in FY 2016-17 for matching consideration to the Board of Regents Support Fund Endowed Superior Graduate Student Scholarships subprogram. Dr. Mayfield was provided with the FY 2016-17 Request for Proposals (RFP) and subprogram policy.

Five (5) institutions submitted a total of twenty-nine (29) proposals in the Endowed Superior Graduate Student Scholarships subprogram. Proposals requested a combined total of \$2,560,000. Dr. Mayfield was advised that \$1,000,000 was budgeted for the current funding cycle.

Per the RFP, proposals were scored based on the degree to which they demonstrated the following:

- Quality of the targeted degree program(s) (40 points)
- Performance of the targeted degree program(s) in fostering student success (30 points)
- Appropriateness of the targeted degree program(s) to the mission of the campus/college/department/unit (15 points)
- Relationship of the proposed scholarship to workforce needs, particularly Louisiana's needs as defined by WISE (15 points)

After thorough assessment of the merits of each proposal, based on the goals of the subprogram and the scoring rubric provided, Dr. Mayfield established a rank order and provided funding recommendations along with brief summary reviews of each proposal. Recommendations are consistent with the total funds budgeted.

A complete rank order of proposals submitted is included in Appendix A. The external review recommends that fourteen (14) proposals submitted under the Endowed Superior Graduate Student Scholarships subprogram be funded in the amounts specified in Table I. Table II provides a rank-order list, with scores, for proposals not recommended for funding. Appendix B consists of brief narrative assessments of submitted proposals and Appendix C contains a listing of all proposals submitted to the subprogram during FY 2016-17.

Requests for match far exceed the total amount of funding available. The external reviewer notes that several proposals included in Table II scored well above the minimum required for funding and could be matched if additional monies became available.

All applicants are reminded that the Board of Regents established the Endowed Superior Graduate Student Scholarships as a competitive subprogram. The RFP sets minimum required elements for the proposal as well as the scoring rubric for the competitive review; applicants are strongly encouraged to review this guiding document prior to submitting proposals. As is noted in many narrative assessments, proposals often did not

hew to the requirements or provide the information and data needed for the reviewer properly to assess the request for match. In such cases, the reviewer could only evaluate the proposal as written and score accordingly. In many cases, the lack of appropriate information and data likely dramatically reduced the proposal's score and the recommendation for funding.

Dr. Mayfield commends the Board of Regents for making funds available for scholarship matching across graduate education. These endowed scholarships will likely become a key component of each campus's package of support for graduate students and post-doctoral fellows.

While the subject area is clearly of importance to Louisiana, this proposal does not directly address the quality of the affected graduate program in Geology and Geophysics nor does it give any but anecdotal evidence to indicate the program's ability to foster student success. Quantitative data in support of general statements and anecdotes would greatly strengthen the proposal. The alignment with departmental mission and workforce needs is excellent. Funding is not recommended

LSU A&M's Medical Physics program appears to be of high quality and a significant asset to Louisiana. The proposal is strong and well presented. The reviewer would have liked to see more specific data concerning quality of training and student placements in Louisiana, to get a better sense of the program's real impact. Match of \$120,000 is recommended.

The Master's program in Analytics clearly is an important program for Louisiana. The proposal could be made stronger by giving quantitative measures of program quality and quantitative placement data; information about placements in Louisiana would be particularly helpful given the emphasis in the proposal on local and regional needs and impact. Given the program's budgetary restrictions, no funding is recommended at this time. Matching of \$40,000 is recommended.

This is a well-written proposal that thoroughly presents all the information necessary to assess its viability, impact, and responsiveness to BoRSF program goals. The Energy Law program is clearly tailored to the needs of Louisiana, focused strongly on students, and of very high quality. Match of \$40,000 is recommended.

This proposal, for the interdisciplinary Materials Science focus, discusses science more broadly, rather than "materials science," making it difficult to assess the real quality of the program for which matching is sought. The proposal provides only minimal information about student success, and does not address the need for PhD materials scientists in the Louisiana economy. Funding is not recommended.

All three programs are high quality, innovative and in different ways aligned with Louisiana workforce needs. Match of \$160,000 is recommended.

This is a strong program with outstanding student placement that aligns well with the State workforce needs. Data on placements in Louisiana would be helpful to understand the direct local and regional impact of support. Matching of \$40,000 is recommended.

Matching to boost the funding level of the existing Lamar Family Post-doctoral Fellowship in the Manship School of Mass Communication sounds like an excellent opportunity for the campus, but the proposal does not specifically address the criteria outlined in the RFP. There is only minimal discussion of program quality and no discussion of alignment with workforce needs. No funding is recommended. A retooled proposal that is responsive to the Board's policy and guidelines would likely be highly competitive.

This well-written proposal effectively argues the role of the LSU Law Center in training lawyers who are much needed in the Louisiana economy and society. Though specific data related to student placements in Louisiana would strengthen the proposal, it is evident that many of the graduates establish their careers in the State. Match of \$80,000 is recommended.

This proposal requests scholarship match for a small program in Business Administration with a concentration in Management. The program admits two to three PhD students per year. The quality of the program is difficult to assess from the information provided, though data do show two drops over the last three years, which is problematic. This is offset by 100% placement of graduates, with two staying in Louisiana. Impact on workforce needs appears to be moderate. No funding is recommended.

This program in Pathobiological Sciences at the LSU School of Veterinary Medicine largely produces researchers specializing in infectious disease. The proposal does not directly address the criteria for assessment. In particular, there is discussion neither of student success nor of the alignment of the program with State workforce needs. The discussion of program quality, while reasonable, could be better supported and more convincing by citing appropriate data. Funding is not recommended.

The field of electrical and computer engineering is clearly of great importance to workforce development in Louisiana. The proposal focuses most of the narrative on the College of Engineering rather than the program, which is not helpful in determining the quality of the specific area for which matching is sought. Only minimal data are provided which might allow the reviewer to judge program quality; almost no data concerning student success are included. Table 1 cites the five-year graduation rate as 25% – if accurate, an extremely low rate – with no explanatory comment in the narrative. If this rate is correct, it warrants some discussion in the proposal. Funding is not recommended. Tailored to the program requirements and guidelines, this project could be highly competitive.

Petroleum engineering is clearly of critical importance to Louisiana's monetizing of its natural resources and development of its workforce. Most of the proposal narrative focuses on the College of Engineering rather than the particular program to be supported, making it difficult to assess. As with proposal 012EGS, data are minimal which might allow the reviewer to judge program quality and almost no data concerning student outcomes and success are included beyond the five-year graduation rate and the average time to degree. No funding is recommended. Tailored to the program requirements and guidelines, this project could be highly competitive.

This master's program in Biological Sciences evidently produces graduates important to Louisiana. This program, producing engineers with expertise in resource extraction, is nationally recognized and aligned with Louisiana's economic health. The proposal well describes the quality of the training and the need in the Louisiana workforce for its graduates. Matching of \$160,000 is recommended.

Louisiana has a strong need for community-oriented, trained Psychology graduates who are willing to work in education settings. Tulane offers a high-quality program that has significant impact locally and

regionally. Though the need for these students is clear, the proposal would be improved by inclusion of quantitative data supporting claims for program quality and student placement. No funding is recommended at this time due to lack of available monies.

The MBA program at the University of Louisiana at Monroe focuses on the needs of the regional community. The program is well regarded and has received national recognition. From the data provided, it appears that retention has been a recent problem, though the program appears to have had some success in remedying this through selectivity in admissions. Matching of \$80,000 is recommended.

The proposal for support of the Marriage and Family Therapy program lacks evidence of program quality. The extremely high ratio of 14.6 PhD students to one faculty member (73 students to five faculty) is of great concern and the proposal should better address how such a high ratio works in practice, as it does not appear to be possible to provide individualized guidance typical of the PhD with such an imbalance. The program likely does a sound job of graduating therapists, though evidence of this should be provided. Self-reported placement seems to be good; supporting data would help to verify this and even strengthen the proposal's argument. The workforce needs section should also be strengthened, possibly in relation to preparation of therapists. No funding is recommended.

As commented in relation to proposal 023EGS, the Marriage and Family Therapy proposals need to provide more and better evidence of program quality, including addressing concerns about the doctoral program's high student-to-faculty ratio. The reviewer similarly urges inclusion of additional data related to student placement as well as workforce contributions. No funding is recommended.

The proposal requests matching for a scholarship in support of the new Gerontological Clinical Nurse Leader (CNL) program at UL Monroe. Because this is a new program without historical outcomes data, the case for program quality should be strengthened. Similarly, student success is almost impossible to gauge, though an account of mentoring and monitoring procedures in place to ensure retention and completion would be helpful. This program does address a very clear workforce need, and one that is felt broadly across the locality, region, and nation. Matching of \$40,000 is recommended.

The proposal requests support for UL Monroe's relatively new program in Public Administration. The program quality appears to be good. Given the newness of the program, student success is difficult to assess reliably, though early graduates seem to be doing well. There are certainly workforce opportunities for graduates in this field, though need within Louisiana is less clear. An analysis of local/regional demand and data related to opportunities for program graduates would be helpful. Due to lack of available monies, no funding is recommended at this time.

Holders of doctoral degrees in Toxicology can readily find jobs in industry and government, though this proposal would be strengthened by additional information related to the particular need and workforce opportunities in Louisiana for such expertise. The program quality appears to be high and student graduation rates are excellent. Matching of \$40,000 is recommended.

It is very clear that Louisiana needs significant expertise in K-12 education, and that this program could help to meet some of this demand. The proposal would be strengthened by the inclusion of quantitative measures of program quality and data concerning student outcomes, particularly related to placement in Louisiana. The argument that a doctorate in education helps ameliorate the need for more classroom teachers is not obvious; it should be supported and strengthened with data or other objective evidence. No funding is recommended. The proposal is of good quality, but it cannot be recommended for funding at this time due to insufficient funds.

The proposal's argument for support would be greatly strengthened by information about the market for these students in the State and region, as well as inclusion of placement data. Objective measures of program quality would also strengthen the proposal. Due to restricted matching monies, no funding is recommended at this time.
