An external reviewer, Dr. John Mayfield, professor emeritus and former Associate Dean of the Graduate School, Iowa State University, evaluated proposals submitted in FY 2017-18 for matching consideration to the Board of Regents Support Fund Endowed Superior Graduate Student Scholarships subprogram. Staff provided the reviewer with the FY 2017-18 Request for Proposals (RFP) and subprogram policy, as well as all proposals submitted and the scoring rubric.

Nine (9) institutions submitted a total of fifty-seven (57) proposals in the Endowed Superior Graduate Student Scholarships subprogram. Proposals requested a combined total of \$5,400,000. Dr. Mayfield was advised that \$920,000 had been budgeted for the current funding cycle.

Per the RFP, proposals were scored based on the degree to which they demonstrated the following:

- Quality of the targeted degree program(s) (40 points)
- Performance of the targeted degree program(s) in fostering student success (30 points)
- Appropriateness of the targeted degree program(s) to the mission of the campus/college/department/unit (15 points)
- Relationship of the proposed scholarship to workforce needs, particularly in Louisiana (15 points)

After thorough assessment of the merits of each proposal, based on the goals of the subprogram and the scoring rubric provided, Dr. Mayfield established a rank order and provided funding recommendations along with brief summary reviews of each proposal. Recommendations are consistent with the total funds budgeted.

A complete rank order of proposals submitted is included in Appendix A. The external review recommends that twelve (12) proposals submitted under the Endowed Superior Graduate Student Scholarships subprogram be funded in the amounts specified in Table I. Table II provides a rank-order list, with scores, for proposals not recommended for funding. Though within the range of scores for which funding was recommended, several proposals listed in Table II could not be recommended due to funding limitations per campus established in the program policy. Appendix B consists of brief narrative assessments of submitted proposals and Appendix C contains a listing of all proposals submitted to the subprogram during FY 2017-18.

Requests for match far exceed the total amount of funding available. The external reviewer notes that all proposals included in Table II scored above the minimum required for funding and could be matched if additional monies became available.

The reviewer notes the following:

1. The amount of matching requested exceeds available monies by a ratio of almost 6:1. The success rate, therefore, is extremely low. Going forward, it would be prudent for campuses to inform development officers and donors of the extremely competitive nature of this program.
2. Several campuses submitted requests for funds that were well in excess of the maximum amount they could expect to be awarded, per limitations detailed in the program policy. In one case, a campus submitted a proposal for a match amount representing 87% of all monies available and more than triple the campus's funding limit. The high demand likely represents the need, felt on a national scale, for new sources of funding for graduate students. In light of the funds available and policy restrictions, however, campuses should do more to prioritize and align their requests with department and campus directions, to ensure the most needed, impactful, and valuable scholarships can be identified by external reviewers.
3. The nature of the program, with its emphasis on program quality and contributions to economic, particularly workforce, development provides an advantage to campuses with well-established, high-performing graduate programs, particularly when funding is so limited. It is incumbent on all applicants to assay the necessary data and analysis to demonstrate how the scholarship request represents a good long-term investment for Louisiana within the program goals and design.
4. This is a competitive program with a published scoring rubric. As is noted in many narrative assessments, proposals often did not hew to the requirements or provide the information and data needed for the reviewer properly to assess the request for match. In such cases, the reviewer could only evaluate the proposal as written and score accordingly. In many cases, the lack of appropriate information and data likely reduced the proposal's score and affected the recommendation for funding.
5. Many proposals are duplicative of one another, when a single graduate program is the recipient of multiple donor contributions to establish scholarships. This makes the review extremely inefficient and adds difficulty in scoring and ranking proposals. Regents staff should consider a mechanism by which a single, consolidated proposal may be submitted for each degree program seeking matching funds, rather than individual proposals for each scholarship request. Any solution should ensure that donors retain naming rights to individual scholarship slots, while allowing applicants to combine requests for the purposes of proposal development, submission, and review.

The reviewer commends the Board of Regents for making funds available for scholarship matching across graduate and professional education. These endowed scholarships will likely become a key component of each campus's package of support for students, professional trainees, and post-doctoral fellows. The competitive nature of the review is extremely important to ensure that funds are distributed in a manner that best achieves the goals of the program and supports the availability of high-quality graduate-level education in Louisiana.

Match Requested:	\$40,000

LSU A&M's Veterinary Medicine program is solid, with good graduate retention and placement. The program is well aligned with University priorities and State workforce needs. The emphasis of this proposal is on food animal veterinary medicine, which is appropriate. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

Economics is a small but good quality program within LSU A&M's College of Business. The proposal would be strengthened by inclusion of student completion data, as well as by a specific case for State workforce needs in relation to the program. No funding is recommended.

This scholarship in Curriculum Theory is focused on recruiting international students. Opportunities for graduates from the program are discussed but the need for such trained personnel, particularly related to Louisiana's workforce, is not. Program quality and outcomes are difficult to assess from the information provided. Though the proposal scored reasonably well, it was not near the top of the large class of applications from LSU A&M. Due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

French Studies at LSU A&M is an outstanding smaller program. Student retention is disappointing, and the proposal would be enhanced by providing more discussion of contributing factors and how they are being addressed. Alignment of the program with State workforce needs, a critical factor in this competition, should also be discussed. No funding is recommended.

Medical Physics at LSU A&M is an important, high-quality program that addresses a significant workforce need in Louisiana. Student quality and retention are outstanding. The requested match of \$40,000 is recommended.

LSU A&M's keyboard program is of excellent quality and has a strong national reputation. Quantitative data on student success would be helpful. The proposal presents a good workforce needs argument. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

LSU A&M's graduate program in Finance is nationally recognized and well aligned with the priorities of the campus and the Business School. The proposal would be strengthened by student retention data. Some discussion of whether graduates are placed in Louisiana is needed to bolster the workforce argument. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

Though the quality of the Geology program at LSU A&M is clearly high, this proposal lacks explicit data on program reputation, student retention, and student success, making a full assessment of program quality difficult. The proposal scored well, and inclusion of this information in a future submission could sufficiently boost it into the funding range. Due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

LSU A&M's Biological Sciences department is large and diverse. The proposal would be strengthened by explicitly addressing program quality and student placements, particularly in Louisiana. In addition, the workforce needs argument should be stronger. Though the proposal scored reasonably well, it was not near the top of the large class of applications from LSU A&M. Due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

LSU A&M houses the premier public law school in Louisiana. The professional programs appear to have good student retention and placement. Lawyers are an important element of the workforce and need for this training for Louisiana is evident. Though the proposal scored well, due to extremely high demand for matching dollars, no funding is recommended.

The LSU A&M School of Music is widely acclaimed. This proposal does not, however, give any clear idea of the breadth of student success (i.e., what fraction of graduate students finish and how many go into performance versus public school teaching or other careers). Without this information it is difficult to gauge program quality or workforce contributions. No funding is recommended.

This proposal is very similar to 010EGS, though focused in the area of public law. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

This request for scholarship support in Mechanical Engineering is very well aligned with Louisiana's workforce needs. The proposal does not, however, address student retention or career placement, which makes program quality and outcomes, critical aspects of a competitive proposal to this program, difficult to assess. Though the proposal scored reasonably well, no funding is recommended.

This proposal is similar to proposal 001EGS, but the scholarship is designated only for Veterinary Medicine students who are selected to care for LSU A&M's mascot, Mike The Tiger. The proposal does not address the need for veterinarians in Louisiana, so workforce contributions are difficult to measure. Student success is discussed only indirectly. Though the proposal scored well, it was not in the top tier of submissions from LSU A&M. No funding is recommended.

This proposal is very similar to proposals 010EGS and 012EGS, though focused in the area of energy law. The proposal would benefit, given its narrower direction and the presence of Louisiana's vital energy sector, from specific information about workforce demand for and placement of energy law specialists in Louisiana. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

Chemical Engineering at LSU A&M is a high-quality program that is very important to the economy of Louisiana. The proposal includes somewhat more information about the energy certificate than proposal 014EGS, though does not indicate the workforce demand for students with the certificate. Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.

Though the proposal scored well, due to funding limits per campus and extremely high demand for matching dollars, no funding is recommended.
