Two external reviewers, Dr. Elizabeth Grauerholz, Professor of Sociology, University of Central Florida, and Dr. Sandra Flash, Associate Vice Provost for Academic Affairs, University of Buffalo, evaluated proposals submitted in FY 2019-20 for matching consideration to the Board of Regents Support Fund Endowed Superior Graduate Student Scholarships subprogram. Staff provided the reviewers with the FY 2019-20 Request for Proposals (RFP) and subprogram policy, as well as all proposals submitted and the scoring rubric.

Ten (10) institutions submitted a total of eighty (80) proposals in the Endowed Superior Graduate Student Scholarships subprogram. Proposals requested a combined total of \$7,160,000. The reviewers were advised that \$680,000 had been budgeted for the current funding cycle.

Per the RFP, proposals were scored based on the degree to which they demonstrated the following:

- Quality of the targeted degree program(s) (40 points)
- Performance of the targeted degree program(s) in fostering student success (30 points)
- Appropriateness of the targeted degree program(s) to the mission of the campus/college/department/unit (15 points)
- Relationship of the proposed scholarship to workforce needs, particularly in Louisiana (15 points)

After thorough assessment of the merits of each proposal, based on the goals of the subprogram and the scoring rubric provided, the reviewers established a rank order and provided funding recommendations along with brief summary reviews of each proposal. Recommendations are consistent with the total funds budgeted.

A complete rank order of proposals submitted is included in Appendix A. The external reviewers recommend that ten (10) proposals submitted under the Endowed Superior Graduate Student Scholarships subprogram be funded in the amounts specified in Table I. Table II provides a rank-order list, with scores, for proposals not recommended for funding. Though within the range of scores for which funding was recommended, several proposals listed in Table II could not be recommended due to funding limitations per campus established in the program policy. Appendix B consists of brief narrative assessments of submitted proposals and Appendix C contains a listing of all proposals submitted to the subprogram during FY 2019-20.

Requests for match far exceed the total amount of funding available. The external reviewers note that numerous proposals included in Table II scored above the minimum required for funding and could be matched in rank order if additional monies become available.

The reviewers note the following:

- 1. The amount of matching requested exceeds available monies by a ratio of more than 7:1. The success rate, therefore, is extremely low. Going forward, it would be prudent for campuses to inform development officers and donors of the extremely competitive nature of this program and take care that applications are fully aligned with campus priorities related to role, scope and mission.
- 2. Some campuses submitted requests for match that were well in excess of the maximum amount they could expect to be awarded, per limitations detailed in the program policy. The high demand likely represents the need, felt on a national scale, for new sources of funding for graduate students. In light of the funds available and policy restrictions, however, campuses should do more to prioritize and align their requests with department and campus directions, to ensure the most needed, impactful, and valuable scholarships can be identified by external reviewers.
- 3. The program prioritizes economic, particularly workforce, development. All proposals should present data and analyses to demonstrate how the scholarship request represents a good long-term investment for Louisiana, particularly related to workforce and the economy.
- 4. This is a competitive program with published guidelines and scoring. As is noted in many narrative assessments, proposals often did not hew to the requirements or provide the information and data needed for assessment per the scoring rubric. In such cases, reviewers could only evaluate the proposal as written and score accordingly. In many cases, the lack of appropriate information and data likely reduced the proposal's score and affected the recommendation for funding.
- 5. Many proposals are duplicative of one another, when a single graduate program is the recipient of multiple donor contributions to establish scholarships. This makes the review extremely inefficient and adds difficulty in scoring and ranking proposals. Regents staff should consider a mechanism by which a single, consolidated proposal may be submitted for each degree program seeking matching funds, rather than individual proposals for each scholarship request. Any solution should ensure that donors retain naming rights to individual scholarship slots, while allowing applicants to combine requests for the purposes of proposal development, submission, and review.

The reviewers commend the Board of Regents for making funds available for scholarship matching across graduate and professional education. These endowed scholarships will likely become a key component of each campus's package of support for students, professional trainees, and post-doctoral fellows. The competitive nature of the review is extremely important to ensure that funds are distributed in a manner that best achieves the goals of the program and supports the availability of high-quality graduate-level education in Louisiana.

COMMENTS ON PROPOSALS SUBMITTED IN FY 2019-20 UNDER THE BOARD OF REGENTS SUPPORT FUND ENDOWED SUPERIOR GRADUATE STUDENT SCHOLARSHIPS SUBPROGRAM

Match Requested:	\$120,000

LSU's Electrical and Computer Engineering program is one of the largest in the College of Engineering (COE). The program appears solid. Among the faculty are three Fellows of the IEEE and several who serve in editorial capacities for scholarly journals. Faculty publications, program rankings and research expenditures (compared to other engineering programs) are average. There is clear evidence of student success, including reasonable retention and publications, as well as graduation rates. The connection to LSU's and COE's strategic plans could be more defined. There are promising career opportunities for these graduates and the LA Workforce Commission projects strong outlook for engineers. It would be helpful to include the percentage of students who are employed in the field and in Louisiana. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

Veterinary schools, including LSU's, are highly competitive and selective; LSU's School of Veterinary Medicine (SVM) is only one of 30 in the country and the only one in Louisiana. It is ranked first among veterinary schools in the Southeastern conference in NIH funding and sixth in the U.S. It would have been helpful to have concrete data on funding and research productivity of faculty, to better assess quality. In terms of student success, the program has a high pass rate on the NAVLE (generally greater than 90%, with the exception of the last year) and a graduation rate of 95%. The students who serve as caretakers for Mike the Tiger have gone on to successful careers. Data on attrition/retention would be helpful. The proposal does not directly discuss how this scholarship aligns with the One Health mission. Clearly, Mike is an institutional icon, and as such his symbolic value is high, but the connection of his care to the larger academic mission is unclear. As a top veterinary program, the SVM produces graduates in a high-demand workforce area, but it is not clear how this scholarship's specific focus (caring for Mike the Tiger) would enhance students' prospects in the job market. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

The LSU Law Center is nationally recognized with reasonably good rankings. It features a strong curriculum and record of student success. No information about faculty accomplishments was provided, however, so it is difficult to fully assess the program quality. In terms of student success, graduation, attrition, and first-time Bar passage rates suggest that the program is fostering success. Graduates are placed in a wide range of prestigious careers, and include six of seven Louisiana Supreme Court justices. Most important, the program has implemented a number of initiatives to support student success. The Law Center's alignment within the University is clear, although it would be helpful to directly connect this scholarship to the mission. Alignment with workforce needs is evident. As a leading law program, its graduates are in high demand. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

This is a long-standing program the enrollment in which appears to be declining (it is not clear whether the decline encompasses both MS and PhD programs as data are combined for these two degrees). It is difficult to discern the quality of the degree programs given the lack of specifics in the proposal. The number of titled professors (10) housed within the department and publications produced are noteworthy, but more data on quality are needed. Similarly, in terms of performance in fostering student success, details are lacking. Claims of an "impressive job placement record," or that many students "publish papers before they complete the PhD program" need to be supported with data (the list of recent job placements provides no dates or indication of sample size). A retention rate of 54% does not seem high. The proposal makes only general mention of Department's research and teaching mission and includes no discussion of how this program or scholarship aligns with larger program or campus roles, missions, or scopes. Information on job placements of recent graduates is provided, but workforce demand is not addressed. The proposal is not recommended for funding.

Match Requested:	\$40,000

Funds are sought for a scholarship to support a graduate student in Kinesiology. This is a large program with low stipend levels, thus the scholarship would be helpful in attracting and retaining highly qualified students. In terms of quality, the faculty appear productive, publishing about five articles per year (for research-active faculty), serving on 27 editorial boards, and holding elected positions in professional organizations. Two NIH grants are currently in progress and research expenditures have increased over

the past few years. In terms of student success, data provided on retention and time-to-degree suggest that students are progressing satisfactorily. There is a clear statement regarding mission on p. 1, but discussion is minimal of how this scholarship aligns with that mission beyond a general account of doctoral students' involvement in teaching, research and service. Job placement is addressed, but not the known demand for employment, although one would assume health care professionals are in high demand. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

Match Requested:	\$40,000

This scholarship would support the Industrial Engineering (IE) program, which is the largest in the state and positioned to grow even more with the PhD in IE. There is little concrete information about program quality, however. Over the past five to six years, it has brought in a total of \$2.8 million in external funding, which is less than other engineering programs. No information on faculty publications or honors is provided. In addition, there is little documentation of the program's record of student success beyond graduation rates and general information about job placements. Other indicators of student success such as retention rates, publications, etc. would be helpful. The proposal indicates that the mission of the IE program is to educate students in fundamentals and contribute to leading-edge research, but does not discuss how the scholarship aligns with this mission or how IE fits within the mission of the broader campus. The scholarship's main strength is a strong alignment with workforce needs; there are a wide range of employment opportunities available to graduates from this program. Contributions to the larger community through recitals, concerts, etc. are also obvious. Although some data are provided for employment, there is little discussion of workforce needs and how this program/scholarship aligns with those needs. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

It would be helpful to add specifics on how this scholarship fits into the mission of the College of Business and campus (beyond simply recruiting and retaining good students and enhancing reputation). There is clear alignment with workforce needs. The proposal is not recommended for funding.

Although some data are provided for employment, there is little discussion of workforce needs and how this specific program and scholarship align with those needs. The proposal shows that this program supports the broader mission of the SVM by providing technology and therapeutic solutions. Jobs in this specific area, especially given the large equine industry in Louisiana, are and will likely continue to be in demand, although this area likely does not employ as many as other areas of veterinary medicine. Further, it is not clear how the scholarship or graduate program aligns with major job placement opportunities noted (e.g., GeauxTeach or DE programs). Data on workforce need would be helpful. Rather than give a wide range for time-to-degree (e.g., 4-6 years), it

is preferable to calculate averages and provide data on retention and graduation. Other than "scholarship holders become the life force of [the program]", no discussion is provided of how the scholarship aligns with broader goals or the department or campus. The proposal generally discusses the need for geologic researchers in the region, but concrete data on job placements and projected growth in the field/demand for specialists are needed. Data on student success appear to be for COS overall, rather than specific to Materials Science, thus it is difficult to assess the success of this particular program. For the COS generally, graduation and job placement rates are high. Materials Sciences is one of LSU's core research areas and essential to the Center for Next-Generation Materials and Manufacturing, which is part of LSU's Strategic Plan. This scholarship clearly aligns with the university's mission. Workforce demand appears to be strong, though it would help to have concrete data to back up this claim. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

Although some data are provided for employment, there is little discussion of workforce needs and how this program and scholarship align with those needs. The proposal includes a clear and obvious alignment to LSU's strategic plan and an excellent discussion of how program is helping to meet workforce needs in an increasingly global world. Funding of the \$40,000 match is recommended.

There is an excellent discussion of how this fellowship will further the Manship School's mission and a clear alignment with workforce needs as jobs for communication/media experts and faculty expand. Alignment with workforce needs seems clear, although more concrete data on job growth projections would be helpful to support the claim that demand exceeds supply. There would seem to be a strong alignment given that the recipient will serve as a curator for the Center, but this connection is not explicit. This program is well

The degree program is competitive, as are all medical programs, and the curriculum appears rigorous, but no information about rankings or faculty prominence/productivity is included. It would be helpful, too, to learn more about where students are placed and time-to-degree. There are strong links to broader missions and a clear need for physicians in the workforce. The match program success rate into residency programs is excellent at is 99.58%. The Rural Scholars Track addresses the high need for medical professionals in rural Louisiana; a success marker is that every parish in Louisiana has an LSUHSC-New Orleans graduate or GME currently in practice. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

Alignment to campus mission and workforce needs is evident. Funding for the \$160,000 match is highly recommended.

The program is clearly well aligned with broader missions, and the need for doctors in the workforce is evident given the high numbers of medically underserved residents in Louisiana. Funding for the \$40,000 match is highly recommended.

Minimal information is provided on the success of students within the programs or after graduation. The proposal engages multiple intersecting units, which appear to support the broader mission of the SOE and the campus. Workforce needs are clearly demonstrated; data on placement of graduates and the focus area(s) of scholarship support would help make the case that the programs are addressing these needs and the scholarship is appropriately targeted. Its accounting program is part of 1% of AACSB-accredited accounting programs worldwide." Student success is well documented. Students taking the CPA exam at UL Lafayette have a consistently higher pass rate than Louisiana or national averages. While the number of degrees awarded has increased, it should be noted that this is likely a function of enrollment growth. The proposal does not adequately address attrition/retention rates and also lacks detail on student mentoring and other support. It is curious why discussion is included of the 2011 National Association of State Boards of Accountancy (NASBA) rankings, as one would assume more recent ranking data are available. The proposal nicely outlines linkages to mission. There appears to be a strong need for accountants. The large number of graduates working in Lafayette/Acadiana speaks to the extent of regional demand. Funding for the \$40,000 match is highly recommended.

The program is too new to have retention/graduation rates or data on employment outcomes; however, the program as described shows positive indicators for student support and success. Funding for the \$120,000 match is highly recommended.

It would be helpful to have more information about the Health Sciences program more generally, since the scholarship extends beyond Nursing. The graduate programs at Lafayette have an innovative consortium arrangement with other Louisiana universities that permits sharing resources, which is a real advantage. The program has clear linkages to the college and campus mission and goals. There is a clear, growing need for nurses nationally and in the region, though a stronger case should be made for health sciences more generally. A more comprehensive explanation of funding strategies, including external funding data, would make the proposal more compelling. Mission linkages are spelled out well in the opening letter but could be more fully addressed within the proposal. Although the workforce demand for biology graduates is not as high as some other areas, this program has been very successful in placing students in both academic and applied careers. The proposal provides a good

explanation of the indirect effects of the program on the Louisiana economy. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

Job placement data are not yet available for the newly approved Nursing program, and very little information is provided on Pharmacy graduates. The proposal would be strengthened by including more information on student success and support. The flexibility to target scholarship funds to nursing or pharmacy was an added benefit. It is difficult to assess this new (2015) online program in Public Administration from the information provided in the proposal. Program quality is not addressed in a substantive way. Four full-time faculty and an unspecified number of part-time instructors are responsible for instruction of a student body that has grown from 28 to 73 in four years. The proposal mentions that part-time faculty have "significant experience in public administration" but provides no specifics to substantiate this claim. More detail on faculty prominence, productivity, and success is needed. The length of time to the degree suggests that students progress through the program at a reasonable rate, and retention rates are strong. While the proposal details potential career fields for graduates, it lacks sufficient outcome data. The opening letter provides some information on linkages to larger missions, but this aspect of the proposal should be further developed. Workforce demand in field appears to be growing, including within the region. Though this proposal scored in the fundable range, available monies are insufficient to recommend funding.

UNO's Business Administration programs are clearly of high quality. The proposal notes that the Accounting program is well rated in AACSB International accreditation, placing it "in the top 2% of accounting programs worldwide." Student retention rates appear low, at 66.5%, though it is not clear how rates compare to national averages or the number of students reflected in the rate, since no data are provided on the cohort size or annual admissions rates. Career placements are impressive; however, percentages of alumni represented in the statistics and outcomes for alumni who left the New Orleans area are unclear. The proposal does not contain information or data on success rates of students on professional examination attempts. The program is central to the mission of UNO's College of Business Administration, but links to other programs and institutional mission are not addressed. There are excellent prospects for workforce growth and demand in the region, especially with DXC locating in the New Orleans area. The proposal is not recommended for funding.

This scholarship seeks to support PharmD students, targeting in particular College of Pharmacy students who reside within the Methodist Health System service area. The program holds an HRSA grant designed to improve the pipeline of African American students interested in pharmacy as a profession as well as to support academic enhancement programs to help these students be successful in the curriculum; this grant is an indicator of a strong program. Unfortunately, the proposal does not address many requirements for

the BoRSF EGS program, including data related to student success, descriptions of the academic, teaching, research, and/or service environments, anticipated workforce outcomes and graduate placement data. The proposal is not recommended for funding.
