Two external reviewers, Dr. Elizabeth Grauerholz, Professor of Sociology, University of Central Florida, and Dr. Sandra Flash, Associate Vice Provost for Academic Affairs, University of Buffalo, evaluated proposals submitted in FY 2022-23 for matching consideration to the Board of Regents Support Fund Endowed Superior Graduate Student Scholarships subprogram. Staff provided the reviewers with the FY 2022-23 Request for Proposals (RFP) and subprogram policy, as well as all proposals submitted and the scoring rubric.

Eight (8) institutions submitted a total of forty-nine (49) proposals in the Endowed Superior Graduate Student Scholarships subprogram. Proposals requested a combined total of \$5,080,000. The reviewers were advised that \$1,100,000 had been budgeted for the current funding cycle.

Per the RFP, proposals were scored based on the degree to which they demonstrated the following:

- Quality of the targeted degree program(s) (40 points)
- Performance of the targeted degree program(s) in fostering student success (30 points)
- Appropriateness of the targeted degree program(s) to the mission of the campus/college/department/unit (15 points)
- Relationship of the proposed scholarship to workforce needs, particularly in Louisiana (15 points)

After thorough assessment of the merits of each proposal, based on the goals of the subprogram and the scoring rubric provided, the reviewers established a rank order and provided funding recommendations along with brief summary reviews of each proposal. Recommendations are consistent with the total funds budgeted.

A complete list of submitted proposals with scores attained is included in Appendix A. The external reviewers recommend that fourteen (14) proposals submitted under the Endowed Superior Graduate Student Scholarships subprogram be funded with the available monies in the amounts specified in Table I; these are listed in rank order. Table II presents a list, in descending order by total score, of proposals not recommended for funding. Appendix B consists of brief narrative assessments of submitted proposals and Appendix C contains a listing of all proposals submitted to the subprogram during FY 2022-23.

Requests for match far exceed the total amount of funding available. The external reviewers note that the majority of proposals included in Table II scored above the minimum required for funding and could be matched in rank order if additional monies become available.

The reviewers note the following:

1. The amount of matching requested exceeds available monies by a ratio of nearly 5:1. The success rate, therefore, is low. Going forward, it would be prudent for campuses to inform development officers and

donors of the extremely competitive nature of this program and take care that scholarship contributions submitted for BoRSF match are fully aligned with campus priorities related to role, scope and mission and that proposals demonstrate this alignment and justify requests in these terms.

2. Some campuses submitted requests for match that were well in excess of the maximum amount they could expect to be awarded, per limitations detailed in the program policy. The high demand likely represents the need, felt on a national scale, for new sources of funding for graduate students. In light of the funds available and policy restrictions, however, campuses should do more to prioritize and align their requests with department and campus priorities and plans, to ensure the most needed, impactful, and valuable scholarships can be identified by external reviewers.
3. This subprogram prioritizes economic, particularly workforce, development. All proposals should present data and analyses to demonstrate how the scholarship request represents a good long-term investment for Louisiana, particularly related to workforce and the economy.
4. This is a competitive program with published guidelines and scoring. As is noted in the narrative assessments, proposals often did not hew to the requirements or provide the information and data needed for assessment per the scoring rubric. In such cases, reviewers could only evaluate the proposal as written and score accordingly. In many cases, the lack of appropriate information and data affected the rank and recommendation for funding. All proposals should include, to the extent possible:
  - Concrete data on program quality that fully support claims of excellence, with context provided to give meaning to any citations of rankings;
  - Retention and graduation rates and time-to-degree averages, in addition to raw counts; and
  - A clear and detailed discussion, supported by data as possible, of how the proposed endowed student support aligns with campus, college, and departmental mission and goals.

The reviewers commend the Board of Regents for making funds available for scholarship matching across graduate and professional education. These endowed scholarships will likely become a key component of each campus's package of support for students, professional trainees, and post-doctoral fellows. The competitive nature of the review is extremely important to ensure that funds are distributed in a manner that best achieves the goals of the program and supports the availability of high-quality graduate-level education in Louisiana.

Endowment Name:	Manuel and Miller Superior Graduate Student Scholarship
Match Requested:	\$40,000

Funds are sought to support students' academic and professional and internship experiences in the Department of Finance. The program is well ranked and, in response to declining enrollments, is offering several new programs (an MSFE degree, graduate certificate and online degree). More information about the faculty would be helpful to assess program quality. The proposal addresses workforce alignment particularly well. Jobs in finance are expected to grow faster than national average. While placement rate is excellent, there are no further data on student success offered. No information is provided on alignment with campus/program mission/goals beyond helping to support new programs.

This endowment would support students within the LSU School of Music with a focus on jazz studies. This is a prestigious program within the School of Music, with award-winning faculty. It is not clear in the proposal, however, if the honors mentioned are for faculty or students. Data on student success are limited. Some examples of placements provided, but no concrete data (e.g., on retention, graduation, placement) are given to assess program success. Alignment with LSU's strategic plan is clear, but discussion and data related to alignment with workforce needs are lacking.

Funds generated by this endowed scholarship would be used to support teaching assistants with travel and research activities within LSU's Geology & Geophysics program. The program is well ranked nationally, and highest in the state. Other indicators of program quality, such as grants/contracts or faculty accomplishments, are not provided and would have been helpful to assess quality. Data on numbers of students enrolled and GPAs are presented, but information provided on student success is very limited. What are the retention, graduation, and placement rates? While it appears that the program overlaps with LSU priorities, more discussion of how these align would be helpful. The discussion of workforce needs is somewhat vague and more concrete data would be helpful.

Funds are sought to support a full-time veterinary student pursuing the DVM who demonstrates financial need. The proposal is very strong in terms of evidence of program quality, fostering students' success and alignment with program/university missions. Specifically, program quality appears to be very strong, as evidenced by grants and research productivity, the number of cases treated per year, and partnerships with other institutions. The program appears to be growing, with a record number of students accepted this year. The curriculum is rigorous and the program highly competitive. Time to degree, pass rates on the license exam, and graduation rates are indicative of a program that fosters student success. The proposal includes an excellent discussion of how the program supports LSU's mission and how this fellowship aligns with the school's mission. The proposal cites an estimated shortage of veterinarians, although more concrete data to support this claim would be helpful. An impressive 64% of licensed veterinarians who practice in the state are LSU graduates, so the program does appear to align well with workforce needs. Full funding is recommended.

Funds would be used to support teaching assistants with travel and research support within the Geology & Geophysics program. It is very similar to 003EGS-23, with identical strengths and limitations.

The LSU College of Science's Materials Science program is seeking funds to support PhD students in this interdisciplinary field. The program consists of faculty from 13 departments, both within and outside the College of Science. The proposal is particularly strong in terms of quality and alignment with the campus mission. The program was recently awarded a \$10 million grant, and 26% of funding awarded to the COS over the past five years supports research in this area. Affiliated faculty appear to have strong research programs, with approximately 32% of students in COS engaged in Materials-Science-related projects. The program is clearly thriving. Graduates in Materials Science areas are employed in academia, industry and other areas and it appears (although it is not clear whether this is for the full COS or Materials Science) that the employment rate is 95%. Retention and graduation data for students in this area are not provided and would be helpful to assess program's ability to foster student success. It also is not clear what percentage are employed after graduation. Alignment with LSU's five pentagon priorities is clear. Given the

interdisciplinary nature of the field, data on Materials-Science-focused employment is not available, but there does appear to be a strong demand for graduates in this area.

The proposal is to support a student in the LSU Law program who specializes in public law. The proposal is particularly strong in terms of the quality of program, fostering student success, and alignment with workforce needs. The program appears to be strong and vibrant, and highly focused on student success, as evidenced by the placements (e.g., the number of LSU law graduates on the LA Supreme Court, 89% employed within ten months of graduation). Retention and graduation rates are very high and Bar passage rates are higher than other state law programs. Alignment with campus and department roles, scopes and missions is only indirectly addressed in the proposal. The projected demand for lawyers exceeds the national average of all occupations, although public lawyers appear to have more challenges in landing positions. The majority of graduates are employed in the state. This proposal is rated above other LSU Law requests due to lower salaries and service aspect of public law careers. Full funding is recommended.

Funds are sought to support post-doctoral fellows in Mass Communication. The proposal is particularly strong in its alignment with mission and goals, and workforce needs. The faculty appear to be active in research and the Manship School has several active research labs, but more information about the strength

of the program would be helpful. Because the post-doctoral fellow would be contributing to the teaching mission of the School, it would be helpful to know the overall enrollment and how it compares to other programs at the University to further assess its vibrancy. Retention rates provided (78-86%, depending on program) are somewhat low. Of PhD graduates, 88% are faculty at other universities. Past post-docs also appear to be successful. Because funds are sought to support a post-doc position, the proposal should demonstrate in more concrete terms the impact of this position on graduate student success (e.g., number of co-authored publications). The post-doc would contribute to the school's mission by engaging in research and teaching in a field in some demand, with strong job growth.

Funds from this endowment would support students in the School of Plant, Environmental and Soil Sciences. The proposal is particularly strong in discussing the importance of the field to Louisiana and society more generally. Other criteria could use more concrete data to strengthen the proposal. There is general discussion of faculty excellence with a few examples of accomplishments, but other indicators of faculty excellence and program quality are less obvious (e.g., the relevance of the Treasure Island series and involvement of departmental faculty in the NRCS grant). There is considerable attention paid to the curriculum, which is positive. Data on retention and graduation are provided, but no data on student placement. The program enhances extension efforts and the general mission of the university, although no information is provided to describe how this fellowship would contribute to such alignment. Job demand in the field is expected to grow 5% in next decade; the importance of and need for plant, environmental and soil specialists is clear.

Funds from this endowment would be used to support graduate students in LSU's Mathematics program. This is a large department (48 faculty) with 85 PhD students. The faculty is highly accomplished, including multiple Fellows of the AMS. Data on grants and contracts were not provided. Completion rates are higher than the national average, and placements of graduates include an impressive list of post-doctoral appointments. Students are winning awards, which speaks to student success. The discussion of alignment with campus role, scope and mission is very general. Workforce demand appears to be significantly higher than average for other occupations, but concrete employment data would be helpful to assess student success.

It is clear that efforts are made to revise curricula to stay abreast of rapid changes in the field, but more concrete evidence of program quality is lacking (e.g., data on the ratio of publications to faculty, teaching awards, and grants). Evidence suggests that the program fosters student success in several ways. Retention and graduation rates are very high, time to degree is excellent, 88% of students have positions before graduation or go on to pursue other degrees, and the CPA pass rate is well above the national average. The proposal explains how the funding aligns with the department's mission to attract top students to the program and provide much-needed funding, although the links to larger goals are lacking. Accounting appears to be a high-demand profession, though the number of students in accounting have decreased. It is noted that 45-50% of LSU's accounting graduates are placed in Louisiana firms. More concrete data on placement would help bolster claims regarding workforce needs (e.g., national and/or state shortages of accountants).

The program enhances extension efforts and the general mission of the university, although no information is included about how this fellowship would contribute to such alignment. Given the coastal needs of the state, this program is closely aligned with workforce demand.

Time-to-degree is respectable. The proposal outlines the program's goals, but there is little discussion of how these link to broader campus goals. Demand for medical physicists appears robust, based on projected retirements and growing health challenges.

The national demand for trained nurses is projected to increase significantly to address population growth, improved access to care, anticipated large numbers of retirements and the aging population. The proposal provides data showing employment rates at or near 100% for all degree programs, with more than 85% of graduates remaining in Louisiana for all degrees except the DNP. Full funding is recommended.

While a brief narrative on job placements is provided, the proposal would be strengthened by the inclusion of more comprehensive outcomes data for program graduates. Full funding is recommended.

Program quality is evidenced by data on external funding amounts and rankings, faculty publications, and approved patents. There is clear linkage of the program to mission and service to the region. Projections show workforce declines in pharmacies nationwide, but demand is expected to increase in Louisiana and nationally in other healthcare settings, including hospitals and clinics. PharmD graduates have a 100% job placement rate. Full funding is recommended.

The academic, research and service environments of the programs are well described. While graduate employment outcomes are discussed, the proposal is lacking data to support the narrative. The proposal does not include a sufficient description of linkages to the University mission.
