An external reviewer, Dr. Allatia Harris, Vice Chancellor of Strategic Initiatives, Workforce Development, Community Relations and Diversity at San Jacinto College, evaluated the proposals submitted in FY 2023-24 for matching consideration to the Board of Regents Support Fund Two-Year Workforce Scholarships subprogram. In addition to the proposals and scoring sheet, Dr. Harris was provided with the FY 2023-24 Request for Proposals (RFP) and subprogram policy.

Ten (10) institutions submitted a total of thirty (30) proposals in the Two-Year Workforce Scholarships subprogram. Proposals requested a combined total of \$1,240,000. Dr. Harris was advised that \$1,000,000 was budgeted for the current funding cycle.

Per the RFP, proposals were scored based on the degree to which they demonstrated the following:

- Quality of the targeted program(s) (25 points)
- Appropriateness of the targeted program(s) to Louisiana's workforce priorities (30 points)
- Performance of the targeted degree program(s) in fostering student success in training for the Louisiana workforce (30 points)
- Appropriateness of the targeted program(s) to the mission of the campus/college/department/unit and system, if appropriate (15 points)

After thorough assessment of the merits of each proposal, based on the goals of the subprogram and the scoring rubric provided, Dr. Harris established a rank order and provided funding recommendations along with brief summary reviews of each proposal. Recommendations are consistent with the funds budgeted.

The complete rank order of proposals submitted is included in Appendix A. The external reviewer recommends that twenty-six (26) proposals submitted under the Endowed Two-Year Workforce Scholarships subprogram be funded in the amounts specified in Table I. Table II provides a rank-order list, with scores, for proposals not recommended for funding. Appendix B consists of brief narrative assessments of submitted proposals and Appendix C contains a listing of all proposals submitted to the subprogram during FY 2023-24.

All applicants are reminded that the Board of Regents established the Endowed Two-Year Workforce Scholarships as a competitive subprogram. The RFP sets minimum required elements for the proposal as well as the scoring rubric for the competitive review; applicants are strongly encouraged to review this guiding document prior to submitting proposals. Applicants should provide all appropriate information and data to argue for the necessity for and impact of the provision of matching funds.

Program retention exceeds the institutional average. The proposal uses Fall 2022 - Fall 2023 data, which is particularly helpful in assessing the program's trajectory. Student support is well articulated. The efforts to "boost retention/graduation" are clear. Funding is recommended for the \$20,000 match.

Overall retention in the affected programs, particularly PTEC, is very good, though freshman retention is low. The faculty are strong. Both Computer Science Studies and PTEC are critical to business and industry in the region. Funding is recommended for the \$100,000 match.

Retention data are strong. The program's growth is good for the region, though NCLEX pass rate information would have been a valuable to assess program quality and impact. The faculty and curriculum are sound, as is support at the institutional level. Funding is recommended for the \$20,000 match.

It is not clear why the proposal prioritizes Medical Assistant and Medical Office Specialist tracks, which lead to three-star jobs. While the original gift was from a healthcare provider that may itself need assistants and office specialists, these are not the four- and five-star opportunities for which this matching support was intended. Data indicate that many of the targeted programs have retention issues. While scholarships may help, other measures are needed to successfully address these problems. Perhaps such initiatives are already in place, but none are mentioned here. While funding of the \$50,000 match is recommended, the institution is urged to consider prioritizing four- and five-star areas in selecting scholarship recipients.

Retention in the business programs addressed in the proposal is reasonable. It is notable, however, that some programs mentioned for scholarship support are not prioritized areas in the EWS program. Funding of the \$40,000 match is recommended, but scholarship support should be limited to students in programs listed for support by the EWS program.

The completion rates in Allied Health are better than average for the institution but are still very low in some of the included programs. Industry partnerships are good and support arguments for workforce development. The goal of helping to offset the costs students incur during clinicals and other aspects of their education is admirable and needed, but the scholarship as designed will be available to all from the beginning of their studies. The proposal does not provide a statement of how BPCC expects to increase completion and the scholarship's contribution to this effort. Funding for the \$30,000 match is recommended.

Retention data are not included, and are essential for understanding program quality. BPCC's new facility is a promising addition, and may help to boost these needed programs. Funding is recommended for the \$20,000 match requested.

Given demand for match in these programs, and to ensure smaller fundable requests can receive support, partial funding of \$100,000 is recommended. Delgado is encouraged to request the remaining \$50,000 match in a future funding cycle.

These programs appear good, but retention data do not allow interpretation of program success as there is no way to compare percentages over time. Scores on licensing exams are good, however, and the programs are producing needed workers. No faculty information is provided. Funding is recommended for the \$20,000 match requested.

LSUE's transfer rate is impressive. The proposal's description of tutoring and lab supports available to students is sound and shows a commitment to student success. Specific references to Louisiana's Star Jobs system and demand data are missing and would have strengthened the proposal. Funding is recommended for the \$10,000 match requested.

Funding is recommended for the \$20,000 match requested.

This is a very strong proposal. The demand clearly exists in the workforce and NTCC is well positioned to make a strong contribution. The program curriculum and faculty are solid. Retention and success in the Early Childhood program should improve. Student supports that facilitate success are not described in the application and might bolster the case for funding. Nevertheless, funding for the \$60,000 match is recommended.

Given the significant dollars requested, partial funding of \$100,000 is recommended to ensure that strong smaller requests can be supported. NTCC is encouraged to request the remaining \$40,000 match in a future funding cycle.

These programs show good retention and completion rates and the faculty roster is strong. There is significant need in the workforce. Program curricula are appropriate. No references are made to student support provided to ensure success. The request for \$180,000 in matching is large, and this is the second proposal from the institution that includes electrical students. To ensure smaller requests can receive funding, partial funding of \$110,000 is recommended. NTCC is encouraged to request the remaining \$70,000 match in a future funding cycle.

The proposal lacks many critical elements to support its match request. It does not mention faculty, alignment with institutional mission, or Louisiana's Star Jobs system (in which the targeted field receives three stars). While this is clearly a quality program with good outcomes, the proposal does not include the required information. No funding is recommended.

The growth in Nunez's Electrical Construction program is excellent, but data indicate that program retention needs improvement. The faculty appear to be strong. Alignment with the program mission is clear, though links to the institutional mission are not referenced. Workforce demand is present, and partnerships seem solid. Funding for the \$20,000 match is recommended.

Data on student success appear reasonable. The Education faculty, though a small number, are well qualified. Funding of the \$20,000 match is recommended.

While it is clear in the proposal that there is a demand for the workers produced in this program, the scope of the program is nebulous. One faculty member is mentioned, but credentials are not provided, though administrators are described. It appears that retention is higher than average for the institution and four graduates are cited, but the number of students enrolled in the targeted

program is unclear. It appears that this program may be extremely small and the impact of any support provided limited. No funding is recommended.

While program administrators are described, there is no mention of the faculty leading this program. The curriculum appears to be reasonable. As with proposal #021EWS-24, it is difficult to understand the scope of this program. Five students completed, with an 80% retention rate, so the total number engaged appears to be very small. No funding is recommended.

Success data are more complete than other proposals and appear to be reasonable. The discussion of retention as less than average for the institution and a need for student supports is commendable in facing a known issue and planning to address it. No description of program faculty is provided. Medical Assistant, which is a two- or three-star job, is included, but this proposal makes a good case for it to be added. Funding of the \$10,000 match is recommended.

Exam pass rates for PN are strong. The RN pass rate is below average, which is cause for concern, though the college is working to address this. General business majors perform better. Funding is recommended for the \$20,000 match requested.

No details are provided relative to curriculum and classes. Funding of the \$20,000 match is recommended.
