IV. PROCEDURE AND DEADLINE FOR SUBMISSION OF NOTICES OF INTENT & PROPOSALS

A. NOTICES OF INTENT

Before a full proposal will be accepted, the applicant must first submit a completed notice of intent form for each research proposal to be submitted. The notice of intent (NOI) <u>must be submitted via LOGAN to the Board of Regents by 4:30 p.m. Central, September 18, 2024</u>. One of the primary purposes of the NOI is to assist the Support Fund R & D Program staff in identifying potential reviewers based on the targeted areas of focus.

<u>NOTE</u>: All rules, regulations, and limitations in the RFP for ITRS and PoC/P research proposals (e.g., limitations on the maximum amount of funds that may be requested per annum, the number of proposals that may be submitted, etc.) also hold true for NOIs. Note that both NOI and proposal submission processes include two steps: submission by the PI to the campus, and campus approval with submission to the Board or Regents; a proposal cannot be accepted by the Board until both steps are completed.
